## EXECUTIVE SUMMARY

The Ad-Hoc Rock Hall Website Advisory Committee (Committee) aimed to identify the technical issues associated with improving the Rock Hall website while at the same time reducing costs. The Committee examined how the procurement process can affect the functionality and usability of the current website. Taking into account the experiences of other municipalities, the Committee concluded that a new approach is necessary in order to satisfy the two purposes of the website: to provide information for visitors, and to engage effectively with Rock Hall citizens.

The Committee recommends that Rock Hall:

- create a clearly defined contract with the current vendor that defines data ownership, domain ownership, and website duties including technical support and content management;
- develop retention and access policies for official email, enforce the use of official email addresses for both elected officials and town staff, and utilize a more user-friendly email application;
- establish a separate domain name (rockhallmd.gov) for the government related portions of the website; and
- announce a Request for Proposals for a new website, combining information for citizens and visitors, with a target date of July 1, 2014 for online launch.

## INTRODUCTION

The Ad Hoc Rock Hall Website Advisory Committee (Committee) was formed in the summer of 2013, through a vote of the Town Council (Council), with the charge of making recommendations of how to achieve an effective and economical website in compliance with the law and to issue a written report to the Council. The Committee was not charged with the redesign of the website. This Report contains the Committee's findings and recommendations.

Before the Committee met for the first time, the Chair attended a meeting of the Greater Rock Hall Business Association (GRHBA) to explain the goals of the committee.

The Committee met regularly in open meetings announced on the Rock Hall website, and kept in touch via email. The Committee: studied the Kent County, Rock Hall, and associated websites; identified areas for Committee consideration; examined Chestertown's December 2010 website RFP to better understand the challenges of the procurement process; developed a questionnaire and contacted other small towns in Delmarva and around the country; and drafted this Report.

The Draft Report was made available for public comment at the beginning of December 2013. It was presented to the Council at a workshop on December 30, 2013, and again at a special public meeting on January 15, 2014. Feedback and comments from the public were taken into consideration and some changes were made. The Chair of the Committee also met with the Kent County Tourism Board on January 29, 2014.

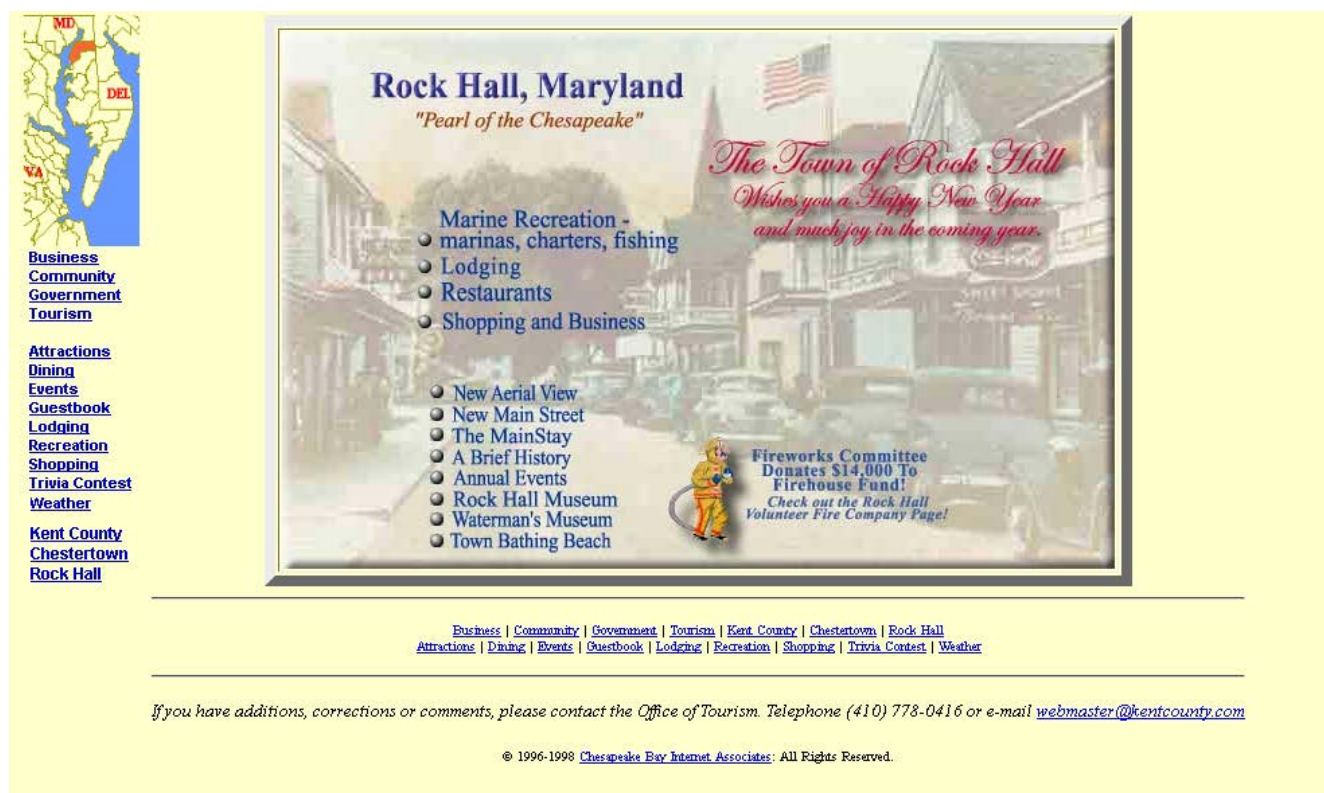

# WEBSITE CONCERNS

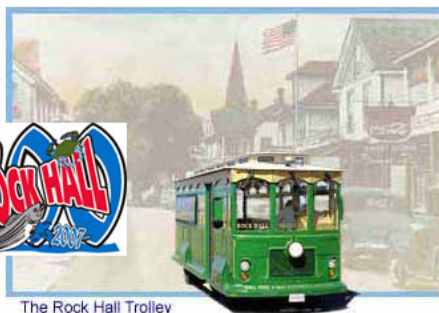
## Background

The Rock Hall website, [www.rockhallmd.com](http://www.rockhallmd.com), contains both tourist-oriented (events, restaurants, marinas, inns, shops, etc.) and municipal government related information (contact information, Council meeting minutes, etc.). It was first established around 1996, and its design was last updated in April 2007.

An informal inventory in January 2014 revealed that of the 320 URLs on [rockhallmd.com](http://rockhallmd.com), 240 pages were government related, 33 pages were tourism related (mostly the business directory), 17 pages belonged to Rock Hall museums, 8 pages were community related, and 25 pages were held by Rock Hall businesses. ## Cost and Legal Issues

**Lack of transparency:** The annual amount paid to the current vendor is high by industry standards for a website with no special features, and Rock Hall has not been provided a breakdown of the amount into design, hosting, hourly rate for content management, domain name registration, etc., nor are hours spent on the site provided. After the draft Report was published in December 2013, the Committee obtained a memo dated May 2013 from the current vendor (Appendix C), but it described all the services as a package. According to this memo, the all-inclusive fee for the website was supposed to cover the cost of a redesign every 4-5 years. The vendor offered a 20 percent discount if the town would sign a three year contract. The vendor also offered a 40 percent discount if the town split off its government section.

**Procurement Rules:** Rock Hall Code (Section 712) provides that any budget expense over \$5,000 must be competed. This has never occurred, despite that the town is paying \$10,000 per year to the vendor.

**Lack of Contract:** No contract between the vendor and Rock Hall exists for the website.

**Private Clients:** There are a number of Rock Hall businesses whose websites exist as subpages of the **rockhallmd.com** domain. (see Appendix B – Inventory) At the January 15 public meeting, the vendor said that these businesses pay him \$150 annually. However, there is no extra registration or hosting cost for maintaining a subpage on a domain. This raises ethical concerns that the vendor is making extra money from private clients using the town’s domain name.

## **Content Management**

**Duplication:** The vendor enters tourist-oriented information for all of Kent County into a database that distributes information to [www.rockhallmd.com](http://www.rockhallmd.com), [www.kentcounty.com](http://www.kentcounty.com) and [www.chestertown.com](http://www.chestertown.com), who are all clients of the same vendor. As a result, the Town and County are each paying to display the same data about Rock Hall, which is only entered once and is kept on a single database for all three clients.

**Business Information Out-of-Date:** It is unclear who is responsible for alerting the vendor to add or remove Rock Hall businesses to its database. There are no written procedures. As a result, for both the Rock Hall and Kent County websites, there is inaccurate information on current businesses. For example, the “shopping” section contains many businesses that closed years ago. Another example is the lodging section. Some of the bed and breakfasts no longer use Webervations, which leads users to mistakenly believe there are vacancies.

**Fresh Ideas Needed:** Rock Hall does not have any staff, full or part time, devoted to tourism despite its significant importance to the local economy. As a result, new multimedia tools are not being utilized. For example, promotional videos could be posted on the website. A “harbor web cam” could be mounted at the Clam House and stream live images. Furthermore, strategically targeted compilations of the tourism information could be introduced. Many town tourism websites include a “weddings” category.

**Government Information Not Updated Frequently:** The government side of the website is time consuming for the town staff to update because it must be done directly in HTML. There is no user-friendly content management system. For this reason, information such as meeting agendas, and even meeting announcements, cannot be provided in a timely manner. The list of committee members (Planning & Zoning, Board of Appeals, Supervisors of Elections, Parks & Recreation, and Museum) is completely out of date and no meeting minutes are posted for these committees.

**Does Not Facilitate Communication:** Interactivity between the residents and the town website is limited. Information is provided, but the only way of contacting the town or its officials is via email. There are no email alerts for meetings, bid opportunities, etc. Some improvement has been made in this area recently with the new social media policy that has allowed Rock Hall to create the Town Facebook page and Twitter account, in addition to signing up for the Code Red service.

**Who Owns the Website?:** The website domain is registered to the vendor instead of the Town. The vendor has indicated a copyright on the website. Intellectual Property Rights concerns have been raised. In the January 15 special public meeting, the vendor indicated that if Rock Hall selected a different vendor, he would not give the new vendor the existing data for the website nor the images.

**Who Has Decision Making Authority?:** The decision making process for creating a new design is unclear. Since the website contains both tourist/business information and government information, there are multiple stakeholders (including the Greater Rock Hall Business Association) and different target audiences.

## **E-mail**

**Liability as Result of Email Addresses Not Used:** Several Council members and the town manager are not utilizing the @rockhallmd.com email domain. According to them, the current vendor's email agent (Horde) makes it burdensome to use the email function. This has substantial legal repercussions for records management and for compliance with the Maryland Public Information Act. The town has established neither a retention policy nor an access policy for official emails, and any emails are automatically deleted from the server after two weeks. In addition, security issues with email addresses not on the rockhallmd.com domain cannot be addressed by the webmaster.

**Forwarding:** It is unclear whether existing email addresses such as [mayor@rockhallmd.com](mailto:mayor@rockhallmd.com) are forwarded to personal email accounts or being read through the interface provided. The practice of forwarding emails, while convenient for the user, is bad for recordkeeping.

## **Technical requirements**

**Improvements:** Due to the absence of a contract, a lack of understanding on what is covered by the current annual fees, and no clear procedure for reviewing the website content and design, there is no process by which improvements could be either offered by the vendor or demanded by the Council or town manager. There is also no way to judge whether any improvements requested are technically reasonable, should be covered by the standard fee or, if not, how much they should cost, etc.

**Website Features for Different Needs:** Requirements for tourist-oriented information and government-related information seem to be significantly different. For example, the visitor information is not changing on a regular basis, except for the calendar, but the government is expected at a minimum to provide meeting announcements, agendas, minutes, etc. In the future, if Rock Hall wants to provide a way to pay utility bills online, apply for permits online, etc., a more sophisticated infrastructure would be required.

**Information Sharing:** The current database setup, where rockhallmd.com shares data with kentcounty.com, creates a vendor lock-in situation. Neither client can make a decision about the vendor without affecting each other. There are concerns whether a new vendor could replicate the same information, either by sharing information electronically with kentcounty.com or starting over. This is particularly important in the case of the events

calendar, which is basically managed by the County but events taking place only in Rock Hall are shown on **rockhallmd.com**.

**Website not easily viewable on smartphones:** The Rock Hall website URL, when put into a mobile device such as an iPhone, is not easy to navigate.

**No in-website search:** Many websites these days offer the ability to easily search within a website. In particular, the meeting minutes are not searchable. They only are accessed according to the date and the year.

**Search Engine Optimization:** The vendor claims that Search Engine Optimization (SEO) is included in the cost of the website. However, a diagnosis of the website revealed that it failed several key SEO parameters: for example, meta descriptions, meta keywords, headings, text/HTML ratio, and XML sitemaps. It does not employ Google Analytics, which is a common method for analyzing visitor patterns.

**Technical Responsibilities:** As it currently stands, without a contract, the technical duties and the content management duties of the webmaster are not clearly defined. The vendor performs both roles, but the town office staff is also responsible for some content management.

## WEBSITE AND EMAIL FUNDAMENTALS

**History:** While The Internet was created by the U.S. Department of Defense Advance Research Project Agency (ARPA) in the late 1960s, the World Wide Web did not exist for the public until 1993. Internet domains, such as **rockhallmd.com**, are managed by the Domain Name System (DNS) which was first available in 1984.

**Domain Names:** Most domains are purchased through and administered by Internet Registrars. Some domains, such as those ending in .mil and .gov, are not typically purchased, but instead granted by appropriate governmental authorities.

The owner of a domain can in turn create sub-domains: **rockhallmd.com** could have the sub-domain **hutch.rockhallmd.com**, which could be an entirely separate website. Additional sub-domains are unlimited and they do not require any further cost or registration.

**Web Hosting:** Websites are hosted on Hypertext Transfer Protocol (HTTP) servers. When a user looks up a page on the web, DNS locates the correct HTTP server, and presents the page to the requester. An HTTP server can host hundreds of different sites, each of which may contain thousands of pages.

Through a method called Virtual Hosting, or shared web hosting, a single server or pool of servers can run many websites operated by multiple owners. A large hosting provider maintains a datacenter with redundant power, air conditioning, backups, application updates/patches, and an around the clock staff and provide a massive economy-of-scale, which is considerably cheaper than to care for it in-house. Below are examples from providers as of November 2013.

**Website Software:** A web site may also utilize back-end databases that contain calendars, searchable and indexable reports, or storage for user-inputted information. Modern servers provide an easy to use yet robust administrative environment that allows for easy edits and fast publishing by non-technical staff; these servers are often called Content Management

Systems (CMS). A well-tuned HTTP server, database, and CMS allows for strong-yet-flexible website management. Web designers increasingly prefer CMS because it allows them to focus on the creativity of the design rather than the functionality. As one example, CMS can automatically incorporate Responsive Web design (RWD), which provides an optimal viewing experience—easy reading and navigation with a minimum of resizing, panning, and scrolling—across a wide range of devices (from mobile phones to desktop computer monitors). This is very important as almost half of all web viewing is done by mobile devices such as smartphones.

Most modern websites collect analytic data on details such as number of unique visitors, geographic range of visitors, system health, bandwidth reporting, and how often each link or picture is clicked. These reports can give Rock Hall insight on how well its website is working.

**Responsibilities:** The technical and visual aspects of a web site are often, but not always, split into multiple roles. The webmaster is typically responsible for look and feel, graphic design, and site content. A system administrator usually cares for the hardware, software patches, and general security of a site. One person can certainly perform both roles.

In the case of Rock Hall, the webmaster may be a town employee who manages content, calendar updates, and otherwise keeps site data current. The website provider could be responsible for the basic appearance of the site, and for technical support (page and memory errors, disk space, DNS configuration, etc). A reputable web hosting vendor should provide hardware support and a number to call when deep technical issues arise. Ultimately the hosting vendor is responsible for the “metal” that the site runs on.

By separating the roles of design, content management and technical support, the annual costs for a website can be reduced. Here are some examples of companies that provide website design services for small towns.

**Email:** Electronic mail (“email”) is transferred between domains using the Simple Message Transfer Protocol (SMTP). When a user sends an email, DNS looks up the Mail Exchanger, or MX record, for the recipient’s domain. The sender’s Message Transfer Agent (MTA) then opens up an SMTP connection with the recipient’s MX server. The MX server delivers the message to the recipient’s MTA. Finally, the recipient views the message with a mail user agent (MUA). These transfers are typically logged by every system that the message passes through, an important part of audit and non-repudiation.

Mail user agents generally use one or both of two available client protocols:

- Post Office Protocol version 3 (POP3) - usually downloaded onto the user's personal computer, although it can be configured to leave copies on the server.
- Internet Message Access Protocol (IMAP) - displayed directly from the server. IMAP is an improvement over POP3 in that the messages can be viewed from multiple locations, including a standard web browser.

There are also proprietary email systems, such as Microsoft Exchange and Lotus Notes, that utilize their own internal client protocols.

The provision of email services as part of virtual hosting is commonplace. The host manages the mailboxes. They also provide read access to the logs so that a webmaster can troubleshoot.

***Email Retention:*** The State of Maryland maintains a web page with recommended email retention policies for state, county, and local governments at

To summarize, emails that include but are not limited to laws, rules, court decisions, policy directives, minutes, births, deaths, and marriages are to be considered of permanent value and kept indefinitely. Other emails related to official business should be kept for a specified number of years. The contents of employee inboxes should be transferred to archival storage at specified times.

Official email communications of a local government are subject to Maryland's Public Information Act (PIA), therefore a clear procedure is needed. A webmaster – who has access to all email for security reasons – should not be allowed to release emails to others without a formal request, and records of the requests should be maintained. This includes both internal and external requests.

## QUESTIONNAIRE RESULTS

Members of the committee reviewed several dozen small town websites on Delmarva and around the country, asking about their website experiences. (See Appendix A – Survey) Having spoken with several towns regarding their websites, the following features seemed to be what made the site “work” for them:

- Have online forms that are automatically sent to the right person, with verification that the message was sent and accepted.
- Online payment and billing capabilities
- Tools that make the site easy to change and update, including photos, calendar updates, and alerts.
- Allow users to sign up for email alerts regarding meetings, new rules, office closures, etc.
- Easy method to contact the webmaster or the website provider for questions and support.
- Train at least two staff or volunteers on how to properly update the site.

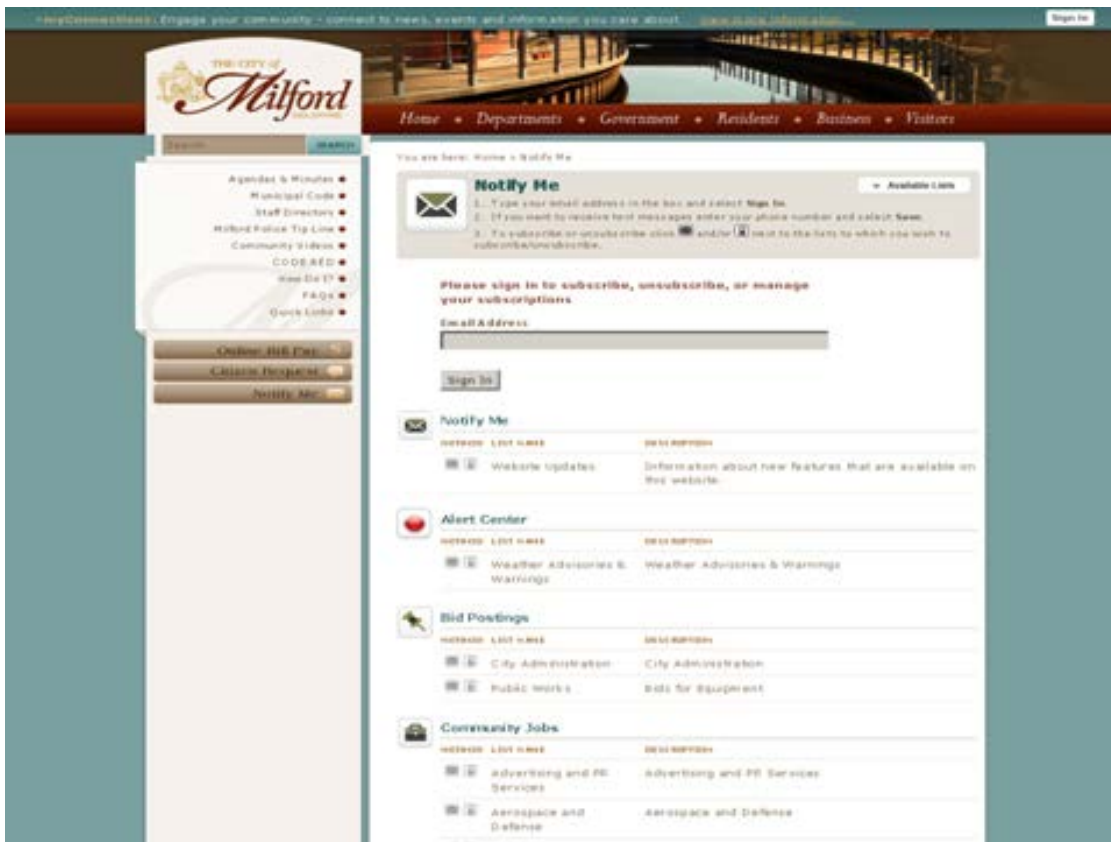
One common thread that we saw in the best sites is that they were inclusive of all their citizens. Information was readily available, community pride quite visible, and the sites encouraged participation between government and the public; very much an “all for one and one for all” mentality that Rock Hall shares.



## RECOMMENDATIONS

### Interim Steps

The Committee urges the Council to take the following interim steps, regardless of whether or not it accepts our “roadmap” recommendations:

1. A contract should be drawn up between the Town of Rock Hall and its web services provider.
2. A non-elected position of the Town of Rock Hall should own the domain, such as the Clerk-Treasurer or Town Manager. Note that it does not have to be registered to the actual person who currently fills the position; it can be registered to the position itself. Before the transfer of ownership, private clients of the vendor should be removed from the **rockhallmd.com** domain, with redirects from the old URLs to each new URL.
3. Clearly define data ownership: Rock Hall should own all town-related data (facts, text, and images).
4. Clearly define who is responsible for changes to the site: Are all changes made by the provider, are changes made by a town employee, or a combination? Procedures should be put in place for major site alterations, with costs specified.
5. All Rock Hall government email should go through Rock Hall domain mail servers, for legal and security reasons. The vendor should utilize a new, more user friendly email agent. The town should devise and implement appropriate retention and access policies for official email.

### Roadmap for a New Rock Hall Web Presence

The Committee recommends that the Town of Rock Hall's current website be split into two separate domain names, one for government and one for tourism. However, ***Rock Hall should seek a vendor who can design a comprehensive website that suits both the needs of the citizens and the needs of the visitors.***

Currently over 75% of the web pages on **rockhallmd.com** are either government or community related. (See Appendix B) The vendor claimed at the January 15 public meeting that the tourism part of the website was more valuable because it attracts more traffic. It makes sense that citizens do not consult the current government pages as often they would with a more interactive, up-to-date site. Because the information on the government site is so outdated, meeting agendas and background on items to be discussed are not provided, and the minutes and the code are not searchable, citizens do not use the government site.

In his memo (see Appendix C) the vendor offered to reduce the cost of the website by 40 percent if the government website were split off. This amount would be \$6,000, which is still over the procurement limit.

The price examples listed in the chart earlier in this Report from other companies that design municipal websites include the entire cost – government information/services, tourism information, etc. Thus, a Rock Hall website could have a “Visitors” tab for no additional cost. Everything, including a business directory, could be easily maintained by a Content Management System (CMS).

The Committee recommends that under the new website:

- a. Mail services should be configured for **rockhall.gov**, through which all government mail would transfer.
- b. The site should contain up-to-date and easily searchable information about agendas, committees, meetings, minutes, and any other municipal information. The committee recommends the installation of a CMS to make editing these pages easy for non-technical users at the town office. While it may be more expensive upfront to have a CMS, it will greatly reduce annual cost and enhance information availability in the long run to turn this responsibility over to the town.
- c. The contract should clarify who designs the site (“look and feel”), who is responsible for content and data updates, and who is responsible for technical support. When asking for bids, each of these aspects will have a cost associated with it. The design of the website should be a one-time cost not an annual cost. However, it is conceivable that the website designer will provide technical support and liaison with the web host as needed.
- d. The Town should meet with a focus group a monthly basis to ensure that the business directory is up to date and to give the community a role in the marketing strategy.

If the current vendor does not bid on the new website, or does not win the bid, the Committee recommends that Rock Hall make an arrangement for its website to exchange information electronically with Kent County’s database for the events calendar. The new Rock Hall calendar would match the “look and feel” of the new website, but contain the same Rock Hall events information as the Kent County online calendar. This way, events would continue to be managed centrally by Kent County’s Office of Tourism and Economic Development, and there would be no need to submit events separately to Rock Hall.

Once the new website is launched, the Committee recommends that Rock Hall ask Kent County to discontinue its listing of Rock Hall businesses, and instead link directly to the Rock Hall website so that there is only one source for this information.

### **Request for Proposals (RFP)**

The committee is vendor neutral and will not recommend a vendor, or participate as bidders themselves. However, the Committee offers its assistance to draft the RFP and provide technical assistance as necessary to evaluate bids. Given that the new fiscal year begins in July 2014, it is important to start this process immediately.

It also essential that Rock Hall does not include any geographic proximity criteria in the bid solicitation. In order to get the best quality website for the best price, the bid must be based on true competition. Local designers can be encouraged, but they must be able to match the skills, services, and costs offered by companies nationwide.

That said, Rock Hall is highly dependent on tourism for its economy and thus the selection of a quality website vendor is very important. The RFP should ensure that the winning vendor has a solid reputation. This can be accomplished by asking for at least three examples of websites that the bidding vendors have designed, along with contact information for the clients of the websites so that the town could follow up to check on their satisfaction.

The Committee strongly suggests that after the Council selects a vendor for the website, the design process should be managed by the Town Manager and his staff. They, in turn, should convene a focus group of the town's stakeholders to solicit feedback throughout the process and on a regular basis after the website is launched. The focus group should include, at a minimum: the Council's Communications Liaison; at least one person with a technical background; 2-3 private citizens; a member of the Museum Committee; and one representative from each of the town's visitor-oriented business categories – e.g., lodging, marinas, restaurants, retail shopping, real estate, and recreation. Furthermore, the focus group participants should be recruited by the Communications Liaison, in order to ensure an appropriate balance and diversity of stakeholder viewpoints about the website.

### **Other Options**

There were options that the committee considered and found that the downsides outweighed any positives. Our reasons for not recommending these options are explained below:

- 1) ***No change, continue with current service model:*** The town cannot legally continue its website with neither contract nor a bidding process. Rock Hall currently pays \$10,000 per year for the website—all purchases above \$5,000 must be put to bid, which has never been done for the entire history of the website. Waiving this bid could put the town into a delicate situation with other large purchases and sets a bad precedent. The Committee also identified the problems listed in this Report with the current service model.
- 2) ***Separate government website, transfer tourism website of current vendor to Kent County as a subdomain:*** Under this proposal, using HTTP redirection the domain **rockhallmd.com** would redirect to the subdomain **rockhall.kentcounty.com**. Anyone who attempts to access **rockhallmd.com** would be automatically redirected to **rockhall.kentcounty.com** and see the same pages they see now. The cost of maintaining registration of **rockhallmd.com** for this redirect would be approximately \$7 per year. This sub-domain could also be accessed through Kent County's existing "towns" link or on a newly created tab or link on the **kentcounty.com** homepage.

The Committee's December 2013 draft Report recommended this option because the business community appeared to be satisfied with the current vendor. However, after extensive discussion with the stakeholders, the Committee now believes that the financial and legal issues associated with this option are not easily surmountable.

Ultimately, money would not be saved and it is unclear whether the quality of the website would improve. The Committee is grateful, however, to the Office of Tourism and Economic Development for their willingness to cooperate with Rock Hall.

**3) *Separate government website, GRHBA maintains tourism website:*** Some members of the Greater Rock Hall Business Association (GRHBA) have suggested that the town should give money from its own budget to GRHBA, who would then be in charge of the tourism website for Rock Hall. We do not recommend this. First, this could potentially be seen as a gimmick to evade the procurement rules. Secondly, the GRHBA would be given taxpayer money, yet have no accountability on how it is spent. Despite the prevalent attitude among GRHBA members that lodging taxes should be spent by the tourism businesses themselves, the reality is that these taxes are collected by law and the Town has the sole authority on how to spend them. In fact, the FY14 budget contains tourism-related expenses of over \$57,000, while the lodging tax is projected to be only \$32,000. Thirdly, there is a concern that only GRHBA members would be listed on the website.

If the GRHBA wants to be in control of a tourism site for the town, we recommend that it be funded in a self-sufficient manner, similar to other chambers of commerce. For example, the GRHBA could charge an annual fee to any business whose link is posted on the tourism site. This would guarantee equal opportunity and also ensure that when businesses close and no longer pay the annual fee, they would be removed from the site. Separating the website into two domain names will allow the future possibility for the town to transfer ownership of **rockhallmd.com** to GRHBA, if they are willing to fund it without taxpayer money. In the meantime, the town should proceed with its own website including a business directory for visitors.

- Post RFP on website

April 2014:

- Deadline for proposals
- Select vendor, sign contract

May/June 2014: Build and test new website (meetings with focus group)

July 2014: Launch new website (to coincide with new fiscal year)

Mayor, Town Council and Town Manager:

In response to a request from the Mayor, I have reviewed the scope of the work CBIA performs for the town of Rock Hall and with this letter will detail the present situation and offer information on options that were mentioned at the last town meeting.

**Why is the cost to Rock Hall higher than Chestertown?**

From year to year the Rock Hall website is larger and requires more maintenance than The Chestertown site. Rock Hall has more major events to promote and more updates to the data bases. The average monthly traffic bandwidth usage of the Rock Hall site is one third more than Chestertown. Disk space usage on the server is more than double that of Chestertown. Rock Hall uses dedicated email addresses (xxx@rockhallmd.com). Back end support for a mail server can be both time consuming and requires additional software cost. Front end support is required when there is an issue with spam, viruses, and basic maintenance such as creating a new email account, phone support to assist in setting up new accounts or assisting in migration to a new mail software or other operational needs.

**What is the current fee for the Rock Hall site and the Chestertown site?**

The Chestertown site is \$595.00 / month.

The Rock Hall site is \$835.00 / month.

**What is included in the fee?**

- Site hosting
- Domain name fees
- email server
- Data base server

- Backend Server support and maintenance
- Unlimited phone support
- Unlimited page updates (including both static and data base driven pages)
- New pages as requested by the Mayor and Council or town office
- New pages as needed to promote major tourism events
- Monitoring and maintaining Rock Hall information on the Kent County site
- Photography services as needed including the occasional release of copyrighted images for use outside of the web site for promoting Rock Hall
- Total redesign and upgrade of the site every 4-5 years  
(The only additional cost would be the fee for new graphics or maps as needed. There would be no additional fees for design, production or the transfer of all page content to the new site)
- Organic Search Engine Optimization(SEO) to keep rockhallmd.com ranked in the search engines

**What are some options moving forward to reduce costs?**

- A discount would be available for an extended agreement for service.  
( Chestertown voted to extend the CBIA service for three years at a fixed cost)
- The government pages could be split out and hosted under another domain name.

**What are the effects of separating the government pages from the rest of the existing site?**

- A reduction in the monthly fee for the existing site off set by whatever cost are incurred to build, host and maintain the new site
- There would only be a link to the government page on the existing site
- The email accounts would have to be switched to the new government URL  
(with subsequent changes to any printed materials using the current email addresses)
- The existing site would benefit from being able to focus on Tourism and business related subject matter.

- CBIA support for the government pages would have to be replaced by either a new contractor or the office staff including but not limited to unlimited phone support, content updating, new page development if needed and email support both on the server and setup on individual mail clients.

Depending on the options chosen, price reductions of 20% could be made over the current fee. If the government pages are split off there would be additional fee reductions. If the government pages are split off and a multi-year agreement can be reached then the monthly fee could be reduced by as much as 40%. Costs incurred separating the government pages would be billed hourly and would be additional.

The Committee recommends that the following requirements be incorporated into the Request For Proposals (RFP) for the new website:

### Technical

- Email system consistent with Rock Hall retention and access policies
- Content Management System
- Events Calendar compatible for data sharing with kentcounty.com
- Business Directory (searchable and also tabbed by category)
- Responsive Web Design
- Ability to search website
- Signup for e-mail announcements in a variety of categories
- Online forms (permits, etc.) and ability to submit these online with payment
- Online payment of utility bills, permits
- Archive of meeting minutes and meeting agendas (searchable by keyword/date)
- Hosting: backups, software patches, security protection
- Search Engine Optimization
- Periodic report of website analytics
- Ability to post video
- Ability to post live streaming, e.g., from webcam or other source
- Separate content into rockhallmd.com and rockhall.gov but with unified “look and feel”

### Costs

Specify the following:

- design fee
- annual maintenance fee after first year
- hosting (included, or does Rock Hall pay directly?)
- email management
- technical support (per hour)
- content changes
- design changes

### Vendor

- No limit on geographic location (but travel expenses not reimbursed)
- Must provide three (3) examples of prior website design and contact information for those clients
- Service Level Agreement that specifies guaranteed webmaster response times
